(SUPPORTERS) Supporters say a flat tax is simple and fair. Everyone pays the same rate, and there is no way to use accounting gimmicks or loopholes to avoid paying taxes. Wealthy people would pay more taxes than middle or lower income people, because they have a higher income.

(OPPONENTS) Opponents say a flat tax sounds good, but it is just a way to increase taxes on middle class and working families who would have to pay a greater share of their income in taxes, while wealthy people would have to pay less. A flat tax is really a tax increase on the middle class.
